REGISTRATION AND ENROLLMENT AGREEMENT

1. It is agreed that the registration fee is non-refundable and the deposit and any other camp fees are only refundable through June 4, 2010. **All camp fee payments and forms must be returned by June 4, 2010.** No reduction or allowance will be made for the late arrival or early withdrawal of a camper, or for the interruption in the camp season due to illness, vacation and holidays.
2. Campers and parents agree to abide by all policies set forth by the Director and listed in the Parent Handbook.
3. The Camp is not responsible for the camper's personal belongings, while in transit or at the camp, if lost, damaged or otherwise.
4. The Director reserves the right to deny, cancel or suspend a child's enrollment if deemed in the best interest of the campers or camp, in which case the deposit or any other unused camp fee will be refunded.
5. Parent's signature allows the Camp Director, or staff to apply medical treatment for that which does not require emergency medical attention. Signature is consent for transportation in emergency vehicles if deemed necessary. A emergency medical form must be completed and returned by June 4, 2010.
6. Signature authorizes The Children's Academy as an agent to transport the enrolled child to and from a predetermined location, if applicable. The signature waives and releases any and all rights and claims that the camper may have against The Children's Academy and its representatives for any and all injuries suffered by the child in transit.
